### Introduction

The Thames Skills Academy (TSA) will operate as a Group Training Association (GTA) - a learning and skills partnership where employers subscribe to on and off-the-job training in order to provide efficient, expertly-delivered skills that meet shared needs across an industry or sector. The TSA will broker and facilitate, and (in due course as a training provider) deliver, a comprehensive solution to meet the marine skills and competency requirements of commercial vessel operators and other marine and port-related organisations within the Port of London and the wider Thames Estuary.

GTAs have evolved in response to the needs of local, sector-specific employers who are directly involved in their governance, and in the development of training standards and the delivery of teaching and learning. They understand the pressures under which businesses operate and how to support them with a highly responsive, holistic and long-term service, covering all aspects of workforce development.

## The Benefits of Membership of the TSA

Being an Employer Member of the TSA will bring a number of benefits in the areas of training and the development of skills and competencies. The TSA:

# **Membership of GTA England**

The TSA is a member of GTA England, the national association of GTAs. This in itself brings a number of advantages and benefits not just for the TSA, but also for its membership.

- Operating on a national level, GTA England effectively engages in lobbying activities with Government, which have resulted in access to influence, funding and capital for members.
- GTA England communicates with members and responds to Government inquiries and consultations. GTA England represents members and employers interests on many fora including: Trailblazer groups for developing employer-led apprenticeship standards; the All Party Parliamentary Group dedicated to the advancement of apprenticeships; and the national advisory group for the Further Education Area Reviews.
- GTA England members can participate in a Peer Review inspection process (Peer Review is a mock OFSTED inspection service undertaken by trained and qualified GTA staff).
- Members can receive free training for Training Officers, including the essential skill of Business Needs Analysis critical for future Apprenticeship Levy arrangements, and for Mentors supporting Apprentices in the workplace, allowing members to differentiate services to employers.

  - attend Members Days to discuss key issues and updates from sector specialists; and
